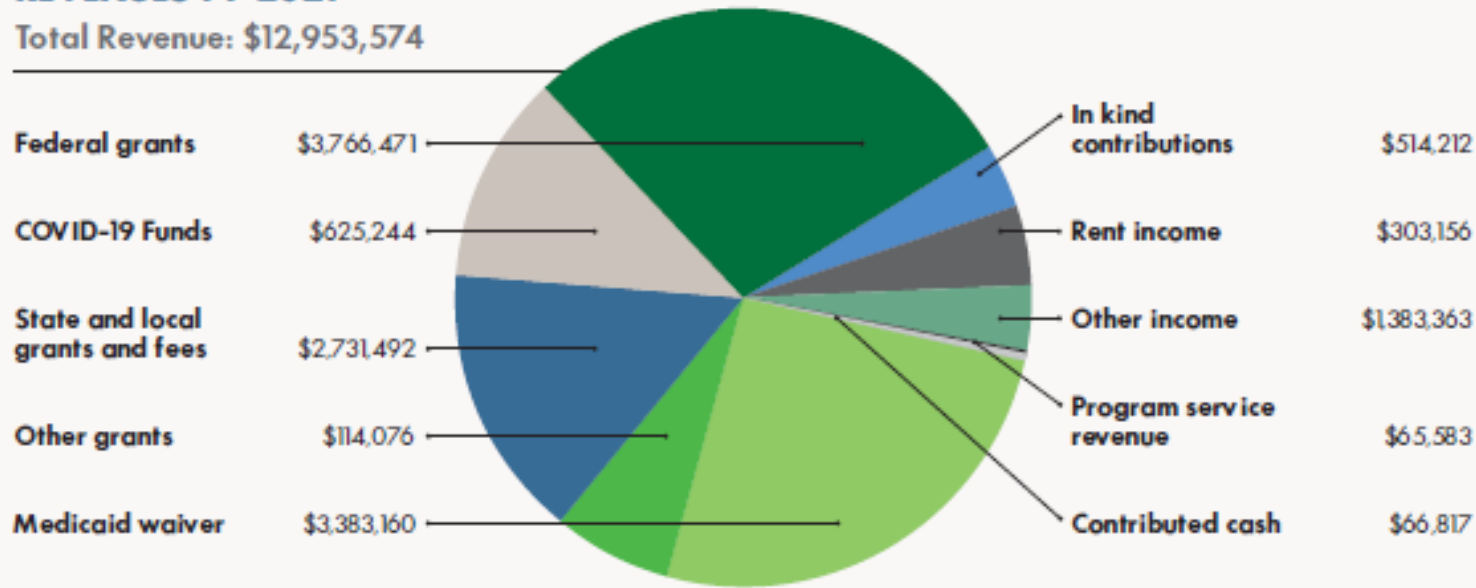

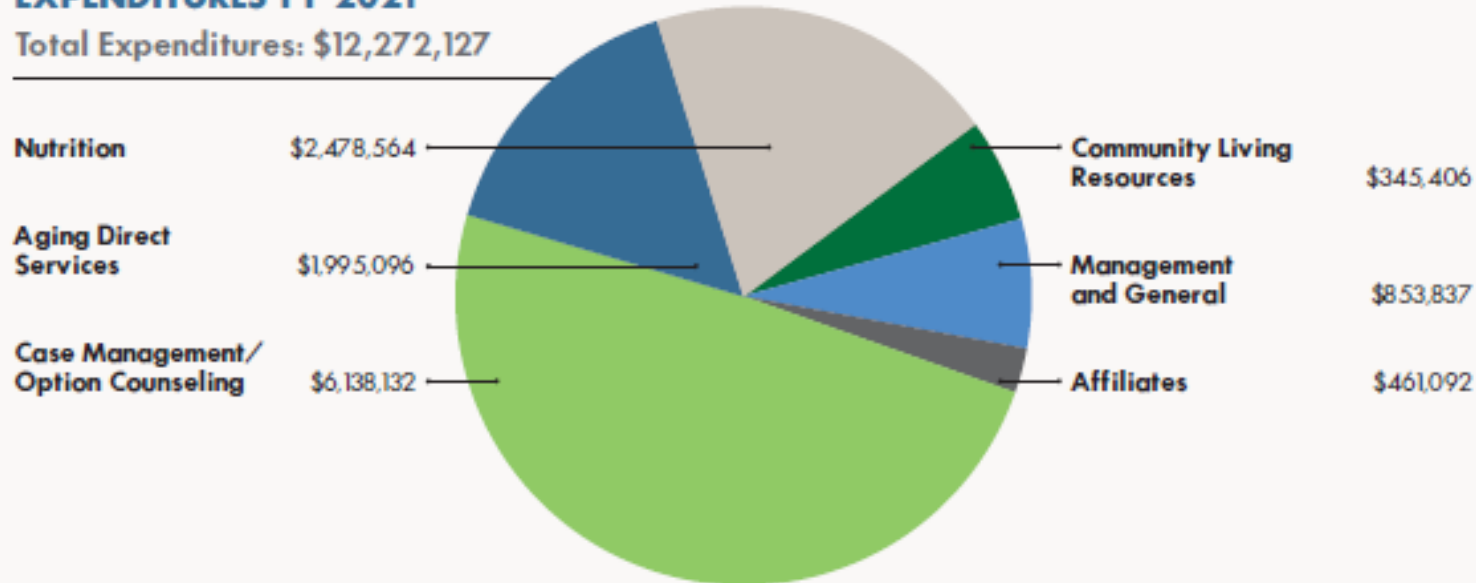
REVENUES FY 2021

Total Revenue: \$12,953,574



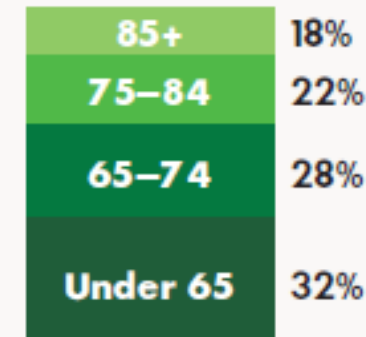
EXPENDITURES FY 2021

Total Expenditures: \$12,272,127

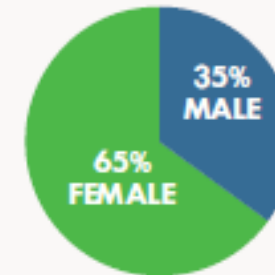

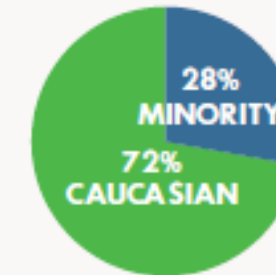
AGE RANGE (Under 1 year – 107 years old)



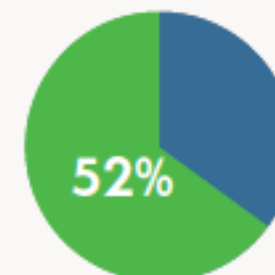
GENDER



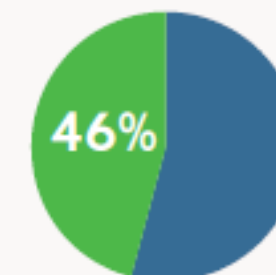
