MESSAGE FROM OUR CEO

AIHS launched into 2020 when we announced in October 2019 our upcoming 45th anniversary of serving older adults, people with disabilities and family caregivers throughout northeast Indiana. We shared this upcoming milestone with over 600 friends and supporters of the agency at the Parkview Mirro Center with featured speaker Mike Farrell aka Captain B.J. Hunnicutt. And we had much to celebrate - new programming in our Family Caregiver Center; new Meals on Wheels delivery trucks to accommodate the increased requests for service; new contracts expanding our Population Health footprint; and a new headquarters as we vacated our former office space at 2927 Lake Avenue for remodel into our PACE Center (Programs of All-Inclusive Care for the Elderly).

In March 2020, all our new excitement came to an abrupt halt as we learned of the global pandemic caused by COVID-19. The pandemic created some complicated situations we never even imagined. We serve some of the most vulnerable populations — older adults, people with disabilities — those especially susceptible to COVID-19 due to underlying health conditions and living situations. Plus, we were seeing a huge influx of community-dwelling individuals requesting services from us for the very first time.

AIHS had to quickly adapt its strategies to meet the increased needs of our current clients and new clients now in need of our assistance. This was especially challenging. We were taking all our skills and abilities in working with these high-risk populations and adapting them to fulfill our mission while keeping our clients and staff safe. Our staff was now working remotely and adapting to telephonic interventions and not providing the in-the-home high-touch services we were used to. That was difficult. We missed getting to physically see our clients and we were worried about them — and they missed us! We knew we had to be flexible and adapt.

And we did. While COVID-19 is not done with us, we have developed mitigation protocols for service delivery and implemented telehealth offerings to put the high-touch back into services. In a time of severe uncertainty, AIHS has withstood the challenges and continued to fulfill our mission. I often say, "flexibility is our greatest strength," and I am so proud that our staff had the ability to turn our operation around 180 degrees without missing a beat. I am so proud of them. I am so grateful that we continue to meet the needs of our community and set a standard worthy of national recognition.

AGING & DISABILITY RESOURCE CENTER (ADRC)

The ADRC provides streamlined access to information, care options, short-term case management and benefits enrollment across a spectrum of long-term care services and supports. Options Counselors can refer as well as connect you to an array of services.

FAMILY CAREGIVER CENTER

The Family Caregiver Center provides support and services to caregivers of individuals age 60 or over or an individual of any age who has dementia or a related disorder. The goal of the program is to reduce caregiver stress and to support the individual's ability to remain in the community with loved ones rather than be institutionalized.

NUTRITION PROGRAM

Aging & In-Home Services' (AIHS) Nutrition Program is funded by the Older Americans Act. (OAA) The OAA supports congregate and home-delivered meals for people aged 60 and older to address the problems of food insecurity, promote socialization and promote health and well-being of older adults through nutrition and nutrition-related services.

POPULATION HEALTH

Population Health focuses on the Social Determinants of Health by meeting people where they are. These individuals are typically people who have had a recent hospital discharge or a complex diagnosis. Our Care Transitions Coaches help empower individuals struggling with the gaps — gaps from lack of knowledge, services, time, preparedness or support.

GERIATRIC & DISABILITY CASE MANAGEMENT

Geriatric & Disability Case Management is a comprehensive approach to promote health and safety in a community-based setting through continuity and quality of services.

PROGRAMS OF ALL-INCLUSIVE CARE FOR THE ELDERLY (PACE)

COVID-19 has delayed but not deterred our integrated care offering – PACE of Northeast Indiana, Our 2927 Lake Avenue location has transformed from our former headquarters into an inviting center at the heart of PACE services. One location for both clinical and social services. One location with an integrated care team delivering person-centered care for safe and independent living outside of an institution for as long as possible. AIHS will be only the fourth organization in Indiana to open a PACE, and the first AAA in the nation to be the sponsoring organization of a PACE. We are pleased to be at the forefront of bringing this CMS-approved model of care to eligible greater Allen County residents. We look forward to the day we can open our doors and welcome our first participants!

Piloted Telehealth Platforms for Video Assessments

Provided 100 age-friendly tablets (GrandPads®) to clients at no charge for use on virtual "face-to-face" case management and with PCP or family













REVENUES FY 20 BY FUNDING
